WHEREAS, the Municipal Cooperative Agreement requires that amendments to the agreement be presented to each participant for review and adopted by a majority vote by its municipal board, and

WHEREAS, the Village of Horseheads is in receipt of the proposed amended Agreement and has determined that it is in the best interest of its constituents who are served by the Consortium to amend the Agreement as set forth in the Amended Municipal Cooperative Agreement.

## **Approval Grant Application for County CHIPS Program**

**Village Manager Nagle:** This is a unique situation. There is a current laborer that will go from 20 hours a week to 40 hours a week. He is retired from the state and will not receive any health benefits and will have a max salary cap of \$34,999. He is not eligible for CSEA membership and this has been discussed at length with the union. They are okay to approve with an MOU- either year to year or the life of the CSEA contract. The funds will be moved from contingency to cemetery to cover the increased cost of moving the individual from part-time to full-time. Discussion ensued.

WHEREAS, representatives of the Village and the Union have met in good faith and have negotiated a tentative successor Collective Bargaining Agreement between the parties to be effective June 1, 2023 through May 31, 2026 and such Agreement requires the approval of the Village Board, and

WHEREAS, the proposed Collective Bargaining Agreement provides for certain compensation and fringe benefit adjustments and the Village's representatives in negotiations have recommended the adoption of the proposed successor Agreement to this Board, and

WHEREAS, Chief Michael Suhey has become aware of the department's potential eligibility for a grant from NYS Division of Criminal Justice Services to fund law enforcement technologies (LETECH) such as surveillance cameras, license plate readers, hand held scanners/readers/radios, body cameras, and other equipment, and

WHEREAS, Chief Suhey has recommended to Manager Nathan Nagle and this Board that the Village would benefit from body worn cameras, and

WHEREAS, the grant does not require a local match, and

WHEREAS, Chief Suhey and Manager Nagle have reviewed the grant program and find that pursuing such grant would be in the best interest of the Village and promote the health, safety, and welfare of its residents.

#### Manager's Report

Final draft for review for an update of the Sign Law is in the packets. Will need to setup a workshop to discuss and from there set a public hearing for passage of the resolution. The changes include date/timeframe for political signs, business signage size, new definitions added. These changes were made based on recommendations from the Planning Board and the Code Department. Date for the workshop is scheduled for October 23<sup>rd</sup> at 5:00pm at the Fire Department.

Letter from the judges regarding a petition opposing the Senate bill limiting judges to lawyers only, no longer open to anyone including police officers.

Discussion ensued, all agree to have the resolution entered into the minutes.

#### Resolution in Opposition to NYS Senate Bill S-00139B and Assembly Bill A-1358B

Resolution by Trustee Skroskznik, seconded by Trustee Cronin

WHEREAS, New York Senate Bill number S-00139B has been passed which, if adopted by the NYS Assembly (A 1358-B) and signed by the Governor, would require all Judges presiding in the 100 largest Town and Village Courts to be licensed to practice law in the State and to have been admitted to the NYS Bar at least five years; and

WHEREAS, The Town and Village Courts in Chemung County are among the nearly 1,200 Justice Courts in the State of New York that collectively handle close to 1 million cases each year; and

WHEREAS, The Town and Village Courts are known as the "Courts Closest to the People" and have broad jurisdiction, presiding over civil and criminal matters, thereby performing a vital role in the New York State Unified Court System; and

WHEREAS, the Village Court of Horseheads is a vital service to our residents and the Chemung County community as a whole; and

WHEREAS, The Justice in Chemung County's Town and Village Courts have pledged to be ever mindful of their neutrality and impartiality, and render equal justice to all, while continually adhering to judicial rules of ethics and pronouncements of the New York State Commission on Judicial Conduct; and

WHEREAS, The Justices are required to be on-call 24 hours a day, 365 days a year to review/sign arrest and search warrants, perform arraignments, and issue orders of protection; and

WHEREAS, The Justices of Town and Village Courts ensure that the rights afforded to defendants by the Constitutions of the United States and the State of New York are provided and protected; and

WHEREAS, The Justices of Town and Village Courts preside over trials involving misdemeanor and violation level offenses, thereby ensuring that the victims of those offenses can be heard; and

WHEREAS, The Town and Village Courts provide a venue for Citizens to pursue a low-cost and efficient procedure for individuals to resolve civil disputes and landlord/tenant matters; and

WHEREAS, the Justices also preside nightly and on weekends and holidays, ensuring that arrested citizens are promptly afforded legal representation, the opportunity to please to alleged charges, and to be considered for release, bail, or incarceration; and

WHEREAS, The Justices continually strive to improve the administration of justice through participation in mandatory education programs, seminars, meetings of the Chemung-Schuyler County Magistrates Association and the New York State Magistrates Association; and

WHEREAS, The New York State Office of Court Administration must certify all as having successfully completed mandatory training both following election and in each subsequent year; and

WHEREAS, The New York State's Commission on Judicial Conduct's most recent annual report (2023) identifies that only 13% of the complaints filed against the judiciary were against Town and Village judges while the remaining complaints were against either "state-paid" judges, (constituting approximately 40% of the judiciary) who accounted for approximately 67% of the complaints received, or against non-judicial entities (20%); and

WHEREAS, This Bill attempts to usurp the right of voters to elect those in their communities who t hey believe to be fair and impartial, and who would best serve that community, whether they be attorneys or non-attorneys; and

WHEREAS, This Bill implicitly suggests that members of a community are incapable of making informed decisions about who should sit in judgment of matters from the straight-forward to the highly complex as may arise in their local courts; and

WHEREAS, this legislative body views the intention of this Bill is not to actually improve the courts, but a blatant an unconscionable attempt by the New York State Bar Association, an organization that represents approximately only fifteen percent (15%) of the State's attorneys, to generate increased opportunities for its members, and to dictate who voters may choose to serve in our local governments.

NOW THEREFORE BE IT RESOLVED, that the Governing Board of the Village of Horseheads strongly, and in unequivocal terms, calls on both the leadership in the Senate and Assembly, and the Governor to reject this poorly/conceived and hastily-fashioned seizure of voters' rights to determine, for themselves, who they would choose to sit as their judges as has been the case for almost two hundred years.

Yesterday a Hydrant was replaced on Center Street in order to not impact school. The shutoff on SingSing Road was changed to October 28<sup>th</sup> to minimize the impact on businesses and schools that would have water off.

As a heads up, have paid \$1.6 million to the contractor without reimbursement. We may need to transfer monies from the General Fund to Water with an interest rate to be set for "borrowing" the monies. The State Health Department is still reviewing the information regarding Phase II

David Pierce is starting Super Saturday, the first of 3 sessions, on October 21<sup>st</sup>. He is doing a good job in his role. Michele is the temp in the Clerk's office and is doing extremely well.

Sullivan Park Update- the pool and the courts will cost \$1.8 million. Need to get the bid packets out to general contractors and engineers.

#### **Around the Table**

**Trustee Skroskznik:** Received a notice from the contractor regarding the water shut off on Monday with plenty of notice. Center Street school had their Fire Prevention assembly- the fire department did a great job!

**Trustee Bill:** Appreciate people coming out to the meetings. Attended the last Neighborhood Watch meeting, next one to be held is 11/28 at 7:00pm. Attended CSEA negotiations, would like to attend future union negotiations, learned a lot from the experience. Next to the old Spectrum building and hotel is going to be a Fire Alarm company. Is there any more word on traffic circle being put in a W Broad and SingSing?

Village Manager Nagle: No, that hasn't been an active conversation in a couple years.

**Trustee Gross:** If you ever have a chance to work on union negotiations, everyone should. It is eye-opening and a great learning experience. Think that another ride-around with the Board would be a good idea. There are many cars parked in yards and junk cars, etc. that need to be taken care of.

**Trustee Cronin:** A reminder to residents that the Village works hard on the road conditions and ensuring that especially heavily trafficked areas are taken care of. They work with other agencies and some roads cannot be done when needed as other agencies (NYSEG, etc.) need to do work that would tear up the new roads. A lot goes into planning of roadwork. The Village of Bath just received millions in grant funding from the Federal government. The Village should look into all grants they can. The new tables look great. Make sure everyone gets out to vote!

Jaime Burgess, Code Enforcement: It's the final weeks of grass season.

Attorney Groff: Camden, NJ has sued 3M regarding contaminants in their water system and it is impacting much of the Northeast, will be looking at the eligibility to participate in this claim as well as another similar claim. Looking into a False Alarm local law. Updating water department rules and regulations- this does not include rates yet. Bullet points for the resolution offered by the judges: would change the way judges are elected/appointed, complaints filed only 13% were against town/village elected judges, the rationale for the bill is through the bar association providing attorneys more employment opportunities.

**Mayor Maloney:** Joe Atkinson couldn't be here tonight, but would like the Board to consider passing the resolution for the state to look into voter fraud.

Discussion ensued.

**Trustee Cronin:** The general thought is for Joe to go to the county first and then we act on it after the county acts. We do not need to follow their lead on what they choose to do just want to have them presented to first.

**Trustee Skroskznik:** Joe has been to the meetings many times, we passed a bill for the judges without thinking twice. Why don't we pass this resolution or offer up to the Board?

Discussion ensued.

Can have Jim Hare and other personnel come and present to the Board regarding voting security within the county.

**Mayor Maloney:** Fire Company is going to purchase additional tools with funds raised and present to the Village. Discussion regarding the Fire District- looking at putting together a tentative budget, hoping to have it done in December or January. Would like the Board to consider as a liaison regarding Fire District conversation after Mayoral term is up



#### **Approve Fire Department PERMA Grant Application**
