• Total Revenue - \$5,959,550







Property Taxes

- Village's Total Assessed Valuation decreased by \$2 Million
- According to Chemung County Real Property Tax, the average full market value of a home in the Village of Horseheads is \$140,957.68
- The Current Tax Rate is \$6.16 per thousand

Water Rates

- Last water rate increased occurred in 2017 and before that, 2014
- Village went through a nearly two year water line project
 - \$5 million total, \$3 million in grant, \$2 million in payback to State
 - Replaced 6,648 linear feet of 44,980 4" main --- 14.8%
 - Replaced 11,470 linear feet of 357,650 All size mains --- 3.2%
 - Replaced 8,791 linear feet of 183,282 4" and 6" main --- 4.8%
 - 76 Fire Hydrants Replaced
 - 349 Service Lines Replaced 9.5%
 - 69 Shut off Valves Installed
